## Plan Descriptions

CCCS utilizes regular review cycles for stakeholders to offer input and analyze programs. Families, staff, and students are surveyed two times a year to offer their input on our school climate and on our program (technology, nutrition, learning loss, service to IEP and 504 students). The results of the surveys are shared with all stakeholders and CCCS responds to the the data. Four times a year, the School Site Council meets to discuss survey data and give input into future plans such as the Expanded Learning Opportunities Grant. For this particular grant, the leadership team at CCCS, the finance committee staff, board members and stakeholders were provided with an opportunity to share how the grant should be used.

A description of how students will be identified and the needs of students will be assessed.

CCCS staff undergoes a continual cycle of student assessment in PLCs (Professional Learning Communities). Staff meet every Friday to look at student data and respond to the data effectively. Students are regularly identified when learning gaps occur, when behavioral gaps occur, and when there is a need for extra social-emotional support. Students are also identified through the SST (Student Study Team) process. The SST team meets every six to seven weeks to track student progress and determine interventions. Teacher and/or parents can refer students to see the school counselor when a student might be identified for extra mental awareness support. Throughout the year, annual IEPs track and monitor student progress and in IEP meetings a student might be identified for extra services. Teachers regularly look at student academic data through vehicles such as the iReady Reading and Math Diagnostics (3 times a year) and through iReady Standards Mastery. Students are identified as needing extra support and/or enrichment based on the information. Teachers also examine CAASPP data such as yearly SBAC scores in ELA, Math, and Science or by analyzing IAB/FIAB student data.

Parents and guardians of CCCS students stay informed about all programs and supplemental learning opportunities through the monthly bulletins, Board Meetings, parent teacher meetings, and the social media page (FaceBook) as a high level of information. The shareholder surveys show staff, students, and families all of the learning opportunities offered at school because they need to provide feedback. On a more personal level, teachers meet with families regularly to inform of supplemental instructional opportunities and resources for students. School Site Council meetings inform stakeholders of opportunities for support as well as the public school board meetings, SST meetings, and IEP meetings.

A description of the LEA’s plan to provide supplemental instruction and support.

CCCS invests in a robust Intervention department. The Intervention team, which consists of a Lead Teacher on Special Assignment and an instructional aide, work with students who need support on a daily basis. Staff has been trained on RTI (Response to Intervention) and implements intervention based on Reading and Math Diagnostics. CCCS also partners with Butte County Office of Education to offer support for students who are in need of counseling and/or mental wellness support. The Intervention team stays after school to offer 1:1 tutoring to students in need. CCCS staff continually learn and are trained in Trauma Informed Practices, De-escalation strategies, Nurtured Heart, Love and Logic, and PBIS in order to meet the needs of students who may be in turmoil. CCCS also has a robust After School Program that offers supplemental support to students through an extended day program.

## Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

*EC* Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the

supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
  - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
  - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
  - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

### **Fiscal Requirements**

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.

- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
